## **RULES AND REGULATIONS FOR CECO'S 20TH ANNIVERSARY LOGO DESIGN COMPETITION**

### **INTRODUCTION**

This document describes the official rules ("Official Rules") of the Conductive Education Center of Orlando (CECO)'s 20th Anniversary Logo Contest. The objective of this contest is to design a logo for the Conductive Education Center of Orlando. Information on how to enter and about the prize is part of these Official Rules. To the extent of any inconsistency, these Official Rules prevail.

### **DEFINITIONS**

"Entry" means a logo design created by the Entrant for this Contest

"Entrant" means the individual or entity that offers the Entry under the terms of this Contest Eligibility.

### **HOW TO ENTER**

1. Initial entries must be submitted by email to [sgranville@ceco.org](mailto:sgranville@ceco.org). Logo entries can be originally created on computer or on paper, but all entries must be submitted in one of the computer formats listed below. The email must also include the release form as presented on the [www.ceco.org/logo](http://www.ceco.org/logo) page, as well as the name, age, postal address, phone number, and email address of the Entrant. The email should also include
  - a. Entrant's logo design(s) submission(s) conforming to the Submission Guidelines outlined below. Entries which fail to do so will be rejected.
  - b. The deadline for Entries is 11:59pm on February 1st, 2021.
  - c. There is no fee to enter the Contest.

### **SUBMISSION GUIDELINES**

The purpose of the contest is to design a logo to commemorate CECO's 20th anniversary celebration. At CECO's discretion, the logo will be used online, in print, on merchandise, etc. . Flexibility is a key requirement, including the capability to resize easily. Please ensure the design is suitable, with minor adjustments, to high quality printing.

Because this logo will be widely distributed, entrants should ensure logos are not in any way similar to existing logos or other copyrighted materials. The logo should emphasize the 20th anniversary celebration.

Designs must be submitted in the following formats: .jpg, .png, or .pdf. Entrants may be asked to convert to an alternate file type for rendering wherever necessary. If the design sketch is illustrated on hard-copy, it must be scanned, or otherwise rendered into one of the above computer formats and submitted. The image must be sized no smaller than 3" by 3". The Conductive Education Center of Orlando (CECO) is not responsible for computer or email related technical problems. Entrants will receive a confirmation email upon receipt of Entry.

### **PRIZES**

Subject to the legal requirements outlined in the release form, the winning design will be officially announced at the 2021 Raymond Golf Classic. Every effort will be made to inform the winner in time for him or her to attend the reveal, but CECO is unable to pay for travel or accommodations.

The winning entrant will receive:

1. A \$250 cash prize.
2. Recognition as the winner of the 20th anniversary commemorative logo competition

## **RULES AND REGULATIONS FOR CECO'S 20TH ANNIVERSARY LOGO DESIGN COMPETITION**

### **JUDGING AND SELECTION OF WINNER**

1. The winning design will be selected by the 20th Anniversary Committee, a committee consisting of CECO staff members, Board of Directors Members, Volunteers, Parents of CECO students, and CECO Ambassadors. Their decision will be final.
2. Committee members who enter the competition will not be eligible to participate in the voting process.
3. CECO reserves the right not to select a winner if, in its sole discretion, no suitable entries are received.
4. CECO reserves the right to disqualify any Entrant or Entry at any time at its sole discretion. No correspondence shall be entered into at this time.
5. No Entry shall be considered without the corresponding Release Form included.

### **INTELLECTUAL PROPERTY**

1. All submitted work must be original and not based on any pre-existing design.
2. All Entries will become the sole property of CECO and may be displayed publicly at any time.
3. The Entrant agrees to transfer all right and title of the entry to CECO in accordance with the Official Rules of this Contest.

### **LEGALITIES**

No purchase necessary.

There will be only one prize winner for this contest.

The prize winner is only entitled to the prize should Entry include the Release form, which waives all rights to further compensation prior to delivery of the prize to the winner. All other entries and entrants are not entitled to any compensation whatsoever.

Winners may accept only the prize as stated in the contest rules. No other substitutions allowed. Failure to comply with this provision will result in forfeiture of the prize by the winner.

CECO reserves the right to use any entries as it deems fit.

By submitting the Release form, the winner releases CECO, its officers and directors, from any and all claims, liabilities, and damages arising directly or indirectly out of the award and use of the prize.

The winning Entrant will assume all financial obligations for local, state, and federal taxes and all applicable fees based on the value of the prize of \$250.

This promotion is void where prohibited by law.

CECO is not responsible for computer, email or internet related technical problems.

Prizes not claimed by April 1st, 2021 by 11:59pm are forfeited and become the sole property of CECO.
